


I, Sharad Kumar Agarwal, Chairman authorized representative of the management / office namely Seth Mussadi Lal Charitable trust on behalf of the institute namely Sardar Patel Institute of Technology, Shikarpur, Bulandshahr (U.P.) undertake that it is a Pvt. (Self financed) institution managed by the Mussadi Lal Charitable trust. The management /office vide trust resolution /order no 01/030399 Date 03/03/199 authorized the undersigned to make an application to the NRC, NCTE for grant of recognition of B.Ed. (Course) with an intake of One Unit (100 Seats). I do hereby solemnly affirm and state as follows:

- (i) That I have read all the provisions of the NCTE Act. Rules & regulations. The application the institution has been submitted as per the provisions of the NCTE Regulation, 2009. That the institution of the management shall be run under Self Finance Scheme ( Self finance scheme of under Govt scheme etc.)
- (ii) That the society/trust is eligible as per the clause 4 of the NCTE regulation, 2009 (specify the category of the institution as per provisions of the NCTE Regulations, 2009)  
Clause 4 (4) of NCTE Regulation 2009
- (iii) That the institution in possession of legally valid land documents and conversion of land has been obtained from the competent authority as per the provisions of the law of the concerned State.
- (iv) That the Institute has constructed building on the legally valid land possessed by the institution as per provisions of the NCTE Regulations. The construction of the building is complete in the form of a permanent structure. There is no temporary structure or asbestos roofing.
- (v) That the institution undertake that the building of the institution is constructed keeping in view the provisions and by laws of the building construction as per the bureau of standards and the same is fully safe and secure to run the teacher training course. The safeguard against fire hazard has been provided in all parts of the building. The institution has submitted the building completion certificate as per the prescribed format.
- (vi) That in addition to the above the infrastructural, instructional and other facilities are provided as per the NCTE regulations, norms, standards and guidelines prescribed from time to time.
- (vii) That admission to the course will be made only after recognition is granted by the concerned Regional Committee of the NCTE and affiliation is granted by the concerned University/Affiliating body.
- (viii) that admission of students, satisfying the eligibility conditions shall be made on merit on basis of marks obtained in the qualifying examination and / or in the entrance examination or any other selection process as per the policy of the state Government/ U.T. Administration and the University.
- (ix) That there shall be reservation of seats for SC/ST/OBC other categories etc. as per the policy State Govt.
- (x) That the supporting and other staff will be appointed as per the guidelines of the state Govt. /the affiliating University.
- (xi) That the institution shall charge only such fee as prescribed by the affiliating body/State Govt concerned in accordance with provision of NCTE (Guidelines for Regulations of tuition fees and other fees chargeable by unaided teacher education institutions) Regulations, 2002 as amended from time to time and shall not charge donations, capitations fee etc. from the students.
- (xii) That the academic and other staff of the institution (including part time staff) shall be paid such salary as may be prescribed by the concerned state Govt. University from time to time through bank.



- (xiii) That the Management shall discharge the statutory obligations relating to provident fund, pension, gratuity etc. in respect of all its employees.
- (xiv) That the Management will make adequate funds available for providing satisfactory facilities and for proper programme implementation.
- (xv) That the accounts of the institution will be properly maintained and audited annually by the audit authorities or a Chartered Accountant, and will be open for inspection.
- (xvi) That the Management will strictly follow all conditions and norms prescribed by NCTE from time to time, conduct the programme in all earnestness, and submit itself to inspection by the NCTE.
- (xvii) That the institution shall make the information or documents available to the NCTE or its authorized representatives as and when required by them. Failure to produce
